REFINERY SAFETY

There are 20 refineries in California and only two (2) use the lethal MHF (Modified Hydrofluoric Acid) in processing their end product; Torrance and Wilmington Refineries. All the rest have been converted to Sulfuric Acid processing. The Wilmington and Torrance refineries are old and urban areas have been built up around them. This is why they are still using the older processing equipment and chemicals in an urban environment.

The Torrance refinery operates to strict safety standards. However, even with that they have had a number of incidents. The incident that occurred on 2/18/15 nearly resulted in a disaster for the surrounding area. If a condition should occur to the MHF pipe lines or tanks (250,000 lbs of this chemical is stored at the refinery), where the chemical is released to the open air, it clings to the ground and travels very quickly as a dense ground-hugging cloud for a 15-mile wide circle causing irreversible internal organ damage, burns and even death. Sulfuric Acid, when released, does not present a danger to the surrounding urban area.

A group of concerned citizens that consist of chemical engineers, geologists, legal professionals, legislative professionals and media professionals, and even a rocket scientist, have formed a group called "Torrance Refinery Action Alliance". Their purpose is to educate residents of Torrance and the surrounding towns as to the danger MHF presents in an urban area, and to put pressure on the cities in the affected areas, to convince the two refineries to convert their processing chemical from MHF to Sulfuric Acid. They also are working with the AQMD, the Senator and Assembly person for the South Bay area, and Governor Jerry Brown's office to get MHF banned from use in urban areas.

In February, there will be petitions at various places in the city for residents to sign. There will also be a number of peaceful demonstrations around the refinery to educate people to the danger of MHF.

This is not an issue of the refinery lacking in safety measures. The refinery management is doing everything it can to ensure safety and as long as there are no unforeseen conditions, we are probably safe. The issue is, a killer refining chemical is being stored in the midst of an urban area in an aged refinery with aged tanks, pipelines and equipment and located in earthquake territory. Excessive ground shaking, or ground movement, human error, electrical problems, or any other unforeseen occurrence can prove to be a disaster to surrounding residents.

A reverse loan allows you to take advantage of the financial value that you've built up in your home. Whether you've paid off your house completely or paid off a good chunk of your mortgage, it allows you to draw on that equity.

This can be a tremendous help if your savings, pensions and social security check aren't enough to allow you to live comfortably in your retirement years. It can also provide help if there's an unexpected financial emergency.

But, it isn't free money. Sooner or later, someone must pay. It be can your heirs, whose inheritance is disappearing as you're collecting reverse mortgage payments.

A common option allows homeowners to continue taking money out of the house until they move out for 12 consecutive months, sell it or die.

During this time, they're not only drawing down the equity in their home but also paying interest on the loan. In effect, they're slowly building up a debt that is secured by the home. If the homeowner finally sells, the loan must be paid.

The heirs can repay the loan from another source. If not, the house will be sold to pay off the balance of the loan. If there's any net equity left, it will go to the estate.

If the reverse mortgage is a FHA insured home equity conversion mortgage, or HECM, neither you nor your heirs are liable if the loan is more than the house is worth. The insurance covers any balance. The lender, as is almost always the case, does get paid in the end.

- 6. **Approval of Minutes:** Minutes of the Board Meeting of October 19, 2016 were moved to be approved and seconded. Board voted to approve. Minutes were approved as submitted.

Motion #1 presented by Bob Lombardi, Treasurer:

Motion #2 presented by Pat Artman, Clubhouse:

Move that New Horizons South Bay Association Board of Directors approve the expenditure of \$2,377 for the installation of waterproof Luxury Laminate Syncorex flooring in the hallway of the Clubhouse. Vendor is American Carpet and Flooring. Source of Funding: Capital Reserves. Board vote taken. 12 voted Yes. One director said "here." Motion Passed.

Motion #3 presented by Bob Lombardi, Treasurer:

Move that the New Horizons South Bay Association Board of Directors present a monetary \$75.00 holiday gift to each of our employees, to be distributed at the employee appreciation luncheon on Friday, Dec. 16, 2016. Cost of this gift will be \$1,350. Source of Funds: General Reserves. Board vote taken. 12-Yes; 1-No. Motion Passed.

8. **Committee Reports**: Reports were read by Committee Chairpersons. Reports, submitted for inclusion, are attached in their entirety to the minutes on file.

Architectural: Tom Kasterko and Gail Standley. The painters are finishing up building #517. Building #521 should be completed by the end of the month. Painting garages in area #5 and Hydro Spraying all garage doors will be worked on after building #521 is painted. No buildings will be painted in December so not to interfere with Christmas decorations. Painting 20 building by the end of the year is on schedule and under budget.

<u>Buildings & Pools: Carl Aleccia</u>. Everything has been running smoothly. There were reported a couple of water leaks. One was when a resident left the water running.

Business Information Systems (BIS): Bud Brown. No report this month.

<u>Clubhouse: Pat Artman:</u> Ceramics room key card readers were installed Nov. 7. The cards are blue. Any resident who would like to use the ceramics room needs to go to the office and sign a waiver, and they will be given the key card; The Clubhouse Committee selected American Carpet to install waterproof vinyl in the hallway; the committee is working on enhancing the ladies room at the gym.

Condo Code Enforcement: Scott Munro. No report this month.

Grounds Maintenance: Linda Crickmore. All work orders are being handled in a timely manner. We completed all but 4 bldgs in Area 5 as far as landscaping but cannot complete any more bldgs because the painters are not painting any more bldgs this year. We are pricing sprinklers for the fairways on the golf course. We plugged the greens and are plugging the tee boxes and redoing them from scratch. The water bill was \$26,691.60 for Oct. The Grounds Dept will no longer be buying plants, shrubs, trees, or flowers for residents. It has become a burden to try

and customize each area and then get the money from the residents to pay for the plants. It is also not the job of the office staff to collect money for the Grounds Dept. so we are discontinuing this practice. If a resident wants to buy their own plants, please submit a work order stating type of plant you wish to purchase, where you wish to plant them, and Grounds Maintenance will review the work order and get back to you. Once a resident buys their own plants they can hire a gardener after hours to do the work. This procedure is printed under Garden and Landscaping in the Resident & Guest Rules and Regulations page 7, items 1 and 3.

Areas 5 and 1 are being repaired by the paving company. They have heavy equipment, so please be careful when you are around those areas. Since the driveways are being repaired too, we are pulling the trash containers out to the street or, as in area 1, the parking lot. This is so the heavy trash truck does not drive on the newly repaired areas.

<u>Insurance</u>: <u>Peter Wu</u>. In the November 9, 2016 Newsletter, the Newsletter Chairman raised three good questions about the health insurance for two senior employees who withdrew from the Kaiser plan and have enrolled in Medicare Part B for 2017. Here are the questions and answers:

- (1) How about giving them the ACTUAL cost? We will reimburse the employees their actual cost of Medicare Part B, which is \$121.80 monthly for each employee. Since they must pay Medicare directly, the reimbursement counts as income, which is taxable in the amount of \$21.95. Hence, the out-of-pocket cost for each would be \$143.76, which is still providing coverage at a lesser cost. The 2017 Kaiser premium would have been \$726.21 monthly each.
- (2) "I don't know about you, but I only pay \$104.90 monthly." Medicare determines the premium to be \$121.80 monthly based on the employee's income and tax status.
- (3) Why do WE have to pay them? New Horizons has a policy of providing full health insurance for all fulltime employees. If you have further questions, I will be happy to answer them.

Newsletter: Gerry Johnson. The Newsletter will have two editions in December – 7th and 21st.

Recreation Council: Linda Falzone. On Friday, November 11 New Horizons celebrated Veterans Day and paid tribute to veterans residing here and to those who have departed. Boy Scout and Cub Scout troop 388 presented and raised the American and MIA/POW flags. Ed Reilly was our emcee. Dale Bowman led all in the singing of the National Anthem. Deon Munro set the Remembrance table with items symbolic of the courage and sacrifice made by our armed forces in war, and their effect upon those who loved them. Bob Lombardi and Paul Cohen read the names of the active and departed vets, and William Jordan provided patriotic music. The team who helped make the day a success: Virginia Allen, Ruben Alvarez, Dale Bowman, Linda Crickmore, Paul Cohen, Linda Falzone, Dale Jones, William Jordan, Barbara Kerr, Kate Karwowska, Kathy Lindbergh, Bob Lombardi, Don Madsen, Ed Mercankaya, Deon Munro, Joyce Paine, Ed Reilly, Jeanne Rennhack, Kelly Rupp, Gary Smith, Carolyn Vismara, Elsie Wu, Judi Wyka, and in particular all the veterans of New Horizons.

The Employee Holiday Luncheon is scheduled for Friday, December 16, for all 18 of our employees along with the Board Directors. We are collecting donations for the Employee Holiday Fund so if you would like to donate, please make your check out to New Horizons HOA and drop it off at the office. The money will be divided evenly amongst the employees and given to them at the luncheon.

Resident & Orientation (R&O): Jennifer Haymore. No report.

<u>Treasurer: Bob Lombardi</u>. The Association hired Vernon Funn, an independent consultant, to perform a reserve study with a site visit. This study is required by our Bylaws to be done every three years but hasn't been done since 2005. This study concluded that the Associations Capital reserves were grossly underfunded, less than 50% funded. Capital Reserve Discussions with the Board of Directors were conducted on August 26th (Special Reserve Study meeting), September 14th (Board Workshop) and September 21^{st (}Board Meeting). The Board of Directors studied the Independent Reserve Study and the Associations reserves and concluded that new Reserve Funds needed to be put into place immediately. The areas of greatest concern were the sewer pipes that are crumbling, the water piping that now has a Band-Aid fix and the shabby fences.

A Budget Summary including a proposed ten-year plan was sent to the Directors for comment and discussions on September 9th. At that time the Directors discussed an increase in HOA fees to \$348. This increase is essential to immediately fund reserves for sewer pipes that were already crumbling. This was discussed and recorded in the minutes of the September 14th Board Workshop. None of the Directors had any objection to the increase in the budget. In fact, many thought this was a great plan and very necessary.

A Budget Committee Meeting was held on September 30th to discuss all the areas of the budget. The members in attendance were Bob Lombardi, Tom Kasterko, Peter Wu, Linda Falzone, Tom Schmidt and Mary Lee Lombardi.

A thorough review of the Budget was done and Bob asked everyone to again read over the package and submit by email any questions or concerns before the packet was submitted to the Directors. This a usual practice done each year. No one sent Bob any suggestions or remarks.

A Budget Meeting was held on October 21st. After much discussion, the Board of Directors voted to approve the Budget of \$348 per month. This budget process was very transparent presenting the Directors with many documents to review and with many discussions over many months.

<u>Secretary: Linda Falzone</u>. Our next Board of Directors election will be held Tuesday, March 7, 2017. If you would like to volunteer to be on the Board you may pick up a copy of the Nomination Petition from the Administrative office. This year there will be seven openings. The nomination period will close Wednesday, January 18, 2017 at the end of the Board of Directors Meeting so stop by soon.

<u>Vice Chairman: Kathy Lindbergh</u>. Due to a comment regarding a director's absence from Board Meetings made by two residents and a director at the November 9th Board Workshop, I researched the matter of director absenteeism from Board Meetings and our Bylaws state that "if a director is absent from four Board Meetings, they shall be removed from the Board." A director has been absent from four Board Meetings. This director asked to further discuss the matter in Executive Session. This will be scheduled.

We are installing fencing and green mesh around the area where we treat the wood in Access 15; Phase 6 of the roofing project has been completed and we came in slightly under budget. It has been reported that there is a serious material shortage, including tile, so Phase 7 will be not begin for several months.

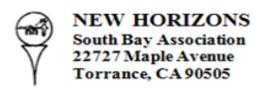
