- 5. Clear up language regarding City Manager and City Attorney.



RENTERS MAKE SURE YOU HAVE "RENTER'S INSURANCE"

Individuals renting units in New Horizons South Bay Association are advised to have a Renter's Insurance Policy.

If there is a flood or fire that causes damage to your personal possessions (ie.furniture, clothing, tv and appliances, carpeting, linens) your "Renters Insurance" will pay to replace those items.

The HOA Insurance covers only "walls out". For example in a fire the HOA would replace the walls and everything outside the walls in the common area. But your personal possessions damaged by the fire are not covered.

If you have to vacate your unit for a period of time during repair or rebuilding, your Renter's Insurance would cover those living out costs. Your Renter's Insurance should also cover liability. (For instance, if your pet bites someone...and you are sued...you would make that claim on your Renter's Insurance Policy. If you leave for vacation: close your windows and TURN OFF YOUR WATER. This will minimize any leaks and discourage break-ins.

Owners are advised upon renting out their units to inform incoming renters to make sure they obtain a Renter's Insurance Policy.

I. MINUTES of the July 17, 2019 Board Meeting were approved as written.

II. HOUSEKEEPING STATEMENT: Turn off/silence cell phones, etc.

III. MOTIONS:

Motion #1 Presented by George Bunce - Buildings

& Pools: Move that the New Horizons South Bay Association Board of Directors approve the expenditure of \$4,500 for the Annual Fire Extinguishers Inspection.

Source of Funds: Maintenance Fund

Vendor: Maximum Fire Protection

Explanation: Required annual fire extinguisher inspection. A vote was taken: 8 Yes and 0 No.

Motion passed.

Motion #2 Presented by Kathy Lindbergh -

Clubhouse: Move that the New Horizons South Bay Association Board of Directors approve the expenditure of \$3,687.65 to upholster Clubhouse chairs in the Lounge. Source of Funds: Capital Reserve

Vendor: Ideal Upholstery & Drapery

Explanation: Six (6) chairs, nine (9) pillows and arm covers to be upholstered. Tax is included in total price.

A vote was taken: 8 Yes and 0 No.

Motion passed.

Motion #3 Presented by George Bunce - Buildings

& Pools: Move that the New Horizons South Bay Association Board of Directors approve the expenditure of \$10,250 to replace the sewer line under building slab at 22629 "A" Nadine Circle, Building #204.

Source of Funds: Sewer Reserve

Vendor: Rob's Plumbing

Explanation: The work has already been completed

A vote was taken: 8 Yes and 0 No.

Motion passed

Motion #4 Presented by Tom Kasterko, Treasurer:

Move that the New Horizons South Bay Board of Directors approve filing a lien against Assessor Parcel No. 7369-004-087 for the delinquency in payment of HOA fees. A vote was taken: 8 Yes and 0 No. Motion passed.

IV. BOARD OF DIRECTORS REPORTS

Architectural – Linda Crickmore: The painters finished Bldg. #122 last week. They are currently working on Bldg. #123. Six (6) touch ups were also completed. After Bldg. #123 is finished they will paint Garage P. They are moving along and our goal is to finish Area 1 by late November/early December.

Buildings & Pools – George Bunce: 233 work requests were completed for July/August in approximately 35 days. We are awaiting delivery of the lights for the Sports Center. We are finishing up roofs on Bldg. #514. Tom, Brian and I are working on a new reroofing schedule. We are ordering new signs for the Sports Center pool area to regulate child usage times and that children under the age of 18 are not permitted in the spa.

Clubhouse & Sports Center – Kathy Lindbergh:

Thank you for coming. We got a new elliptical exercise machine in the Sports Center. This was replaced at no charge as the other one was defective, which was also a new machine. Two chairs in the lounge will be recovered at a time. I will call Ideal Upholstery today after the meeting to order the fabric and start the work. Thanks again, Cita Young and Pat Artman, for helping in the Clubhouse and keeping on top of things that need to be replaced and overall check. I had a very nice turn out for the Clubhouse meeting which is the first Friday of the month at 10:00 AM. Thanks to Joyce Higginbotham for taking the minutes and doing such a

great job and all who attend. Thank you, Joyce Higginbotham, Solange Koblizek and Marlene Krapf, for helping serve the refreshments after this meeting.

Grounds Maintenance – Bob Lombardi: Our water bills are up but less than last year. The sprinklers were all checked but it seems some of the heads are not reaching all areas. The Clubhouse flowers were finished thanks to Phyllis Mathia and Elizabeth McCue. The Sports Center is in the process of removing the roses on the left side of the entrance and more colorful flowers will be planted soon. The plugging and seeding of the fairways have been done. Rich Stoffer had said it might be good to have two golf mats so they would not have to be moved. Brian suggested that peanut type gravel be placed under with bend a board to be place around the mats. No decision has been made at this point. The first tee would be done as experiment. We are getting two estimates on fixing the trip hazards around the community. Joyce Payne said that she wants to have flowers around the other side of the Clubhouse pool once the weeds are removed. We are looking at the signs at either end of the entrance to New Horizons and the flowers are dead Linda and Phyllis will look into what can be done. Residents & Orientation - Peter Wu: For this month, we had four units requiring orientations. Three are owner occupied and one is coresident. We have added five new residents.

Treasurer – Tom Kasterko: We are in the process of gathering information to set up the first draft of the 2020 Budget. This year we need an on-site visit from the Reserve study company. It will take place the second week in September. I would like to have the first draft of the budget discussed around that time. At this time, we have over \$3 million in reserve funds. Half of this is for our new roofs. At the beginning of August, we had \$950,000 in operating cash. We purchased two \$250,000 CDs at 1.95%. We are well funded to pay for the projects for this year. These projects are: the asphalt, sidewalks, sewers, decks and weather permitting at least five new roofs.

Secretary – Julie Dojiri: Our new office staff member, Lynette Hazly, is doing an outstanding job. Her computer knowledge has been an asset. We continue to reorganize the office. All owners must provide the Association information pursuant to Civil Code §4041 on an annual basis. We have inserted this form in the Newsletter. Please complete and turn in the form by September 30th. Please remember to include your signature. There are blank copies of the form in the office. Thank you to all owners who have already submitted their forms. I would like to thank Joan Jones. She has been handling all of the insurance documents and cases on our behalf.

Vice Chairman – Gerry Johnson: No report Chairman – Gail Standley: The Directors did an outstanding job reporting important items. Therefore, I do not have anything else to add. **ON-SITE PROPERTY MANAGER - Brian Swink**: In the last 30 days, there were the following work requests: 233 Buildings & Pools, 101 Grounds Maintenance, 20 Clubhouse, 5 Condo Code and 18 Architecture. The Roofing for Bldg. #514 is finishing up. Tom and George are working on a new roofing schedule. We are trying to finalize the bids for the tripping hazards and asphalt projects. The painting team is starting on Bldg. #123. Thanks for all of the positive feedback regarding the Architectural construction signs. If you see work being done without a construction sign, please contact me. Once again, I want to say what a beautiful job the Grounds Maintenance team has done with the Clubhouse front garden area. Please limit the amount of food that is put down your garbage disposals. It may cause future plumbing issues. Put it in the waste in the trash instead. The new light fixtures will be here soon. They finally delivered the new replacement elliptical machine for the Sports Center. We have approved a number of work requests for Decks & Patio work: If your unit is next, you will receive a letter, a week prior, explaining that all items must be moved off of the patios and decks. We are waiting for final approval for rain gutters at the Clubhouse. Multiple bids have been obtained.

VII. INDEPENDENT REPORTS:

Civic Affairs – Julie Dojiri: The City Council has approved to amend some portions of the City Charter for the 2020 March 3rd and November elections. Public hearings are being planned. One consideration will be to have the City Treasurer and City Clerk be appointed instead of elected positions. Andrew DeBlock and Incumbent, Mike Griffiths, are running for our District 6 Council seats. Go to TorranceVotes.org. website to research candidates for information.

Newsletter – Maggie Pagan & Judy Patten – Newsletter is in very good financial shape as income from advertisers has increased. Therefore, we plan to publish a color edition in December. Please submit photos.

VIII. OPEN FORUM: RESIDENTS'/OWNERS' QUESTIONS/COMMENTS:

DMT – On September 19th the Red Cross will present a Senior Disaster Preparedness Workshop. We encourage all residents to attend. October 24th will be the 2019 Shake Out. This is a mock earthquake drill involving the entire community.

CIC: Hosting a fundraiser, Hawaiian Luau Night, on September 21st from 5:00 pm – 8:00 pm. Tickets are \$30 per person. Purchase tickets from a CIC member. See article in the Newsletter or bulletin board flyer for information. The following concerns were presented: trip hazard project, solar panels to alleviate electricity cost, sidewalk repairs, completion of work on Clubhouse and electrical charging stations.

All questions and concerns voiced were addressed.






